Audit opinion - Qualified

Except for the matters reported below in my Basis for Qualfication, on the basis of my review and subject to the matters and recommendations identified below, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
 of resources.

Basis for Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position for the year. The Council has not provided a complete explanation for significant variances within the year. We recommend that the Council provides the relevant audit information as requested within the annual return.

The Council has restated its prior year balances and has not clearly disclosed the reasons for the restatement. The Council has amended its staff costs from £32,234 to £33,822. No corresponding changes have been made to the Council's balance carried forward for the prior year and the Council's opening balance for the current financial year.
