**ADVICE TO PONTARDDULAIS TOWN COUNCILLORS:**

The Councillor's Code of Conduct requires you to declare Personal Interests. Some Personal Interests have to be recorded by you in the statutory public register, **within 28 days** of your election or appointment to office, and have to be updated by you **within 28 days** of any change.

There is an exemption from having to declare "sensitive information"; the Monitoring Officer can advise you about this.

This form enables you to record those interests, or to show that you have no such interests to declare.

**Please remember** that you still have to declare any relevant interests (including those in this Register) where they relate to matters under consideration at a meeting. Please refer to the Councillor's Code of Conduct for the rules on this.

**Personal Interests**

You (Councillors and Co-opted Members) must in all matters consider whether you have a Personal Interest, and whether the Code of Conduct requires you to disclose that Interest.

You must regard yourself as having a Personal Interest in any business of your Authority if it relates to, or is likely to affect any of the following categories.

i	<b>Details of any employment or business carried on by you;</b> SELF EMPLOYED BUT THE MAJORITY OF MY TIME ROTATES AROUND ROLES CARRIED OUT ABOUT ELJM COMMUNITY CHURCH.
ii	<b>Details of any person who employs or has appointed you, any firm in which you are a partner or any company for which you are a remunerated director;</b> NONE
iii	<b>Details of any person, other than your Authority, who has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties as a member;</b> NONE
iv	<b>Details of any corporate body which has a place of business or land in your Authority's area, and in which you have a beneficial interest in a class of securities of that body that exceeds the nominal value of £25,000 or one hundredth (1/100) of the total issued share capital of that body;</b> NONE


