## 6. To discuss and agree Christmas Parade and Grotto plans

As in previous years, the parade walkers and sleigh will meet at the railway station before proceeding to Dulais Glen for light switch on and up to Dantwyn. The Clerk and Councillors will ask various groups and organisations around the area if they wish to participate in the parade. The Clerk will contact volunteers to act as stewards along the parade route.

The Clerk will invite Father Christmas and arrange the purchase of selection boxes. It is planned that hall and grotto decoration will take place on Tuesday 2<sup>nd</sup> and Thursday 4<sup>th</sup> December with clean-up planned for Saturday afternoon/Sunday. Proposed, seconded and agreed by all.

### 7. Update on Christmas Tree plans

The Committee discussed the different options and settled on a forged tree structure in principle. It was also resolved that Cllr. RH enquire with Friends of Kilvey Hill if it is possible to source the Institute tree from there at the end of November. The Clerk will source prices for a forged tree structure for Dulais Glen to be used year-round to celebrate various significant dates in the calendar. Proposed, seconded and agreed by all.
